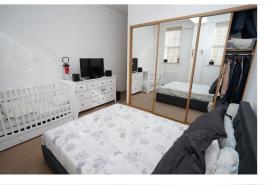

The building was previously the main campus of the University of East London. Located next to Mayesbrook Park, within walking distance to Sport House and approximately 35 minutes to Canary Wharf and Fenchurch Street Station. With high ceilings and boasting a 25' lounge and en-suites to both double bedrooms, this property also has the added benefit of a study. The property also benefits from double glazing and gas central heating (untested). Externally the property also comes with allocated parking and communal gardens.

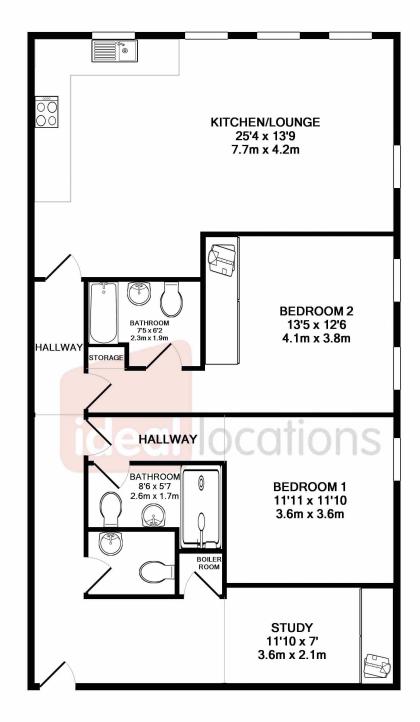
